Surrender Agreement

This Surrender Agreement (hereinafter referred to as the "Agreement") is hereby considered a contractual Agreement between Fullmer Menagerie Animal Rescue (hereinafter referred to as "FMAR", "our", "us", or "we"), a registered non-profit 501-(c)(3) organization existing under the laws of the state of Utah in the United States of America, and the below signed individual (hereinafter referred to as the "Applicant", "you", or "your").

This Surrender Application (hereinafter referred to as the "Application"), including this Agreement, is subject to review and processing by our staff and/or Director. We attempt to process applications within seventy-two (72) hours, however, it may take up to twenty-one (21) days to complete processing. By submitting this Application and signing this Agreement, you hereby acknowledge and agree to the following:

01. We reserve the right to refuse and/or deny you Application, for any reason, and the right to withhold from you why a refusal/denial was made.
02. We do not discriminate against any applicant, in any way, based on any protected classes (e.g. age, gender, race, ethnicity, religion, sexual orientation or identity, etc).
03. Although we make every effort to rescue as many animals as we possibly can, submitting this Application does not guarantee that we will accept your relinquishment of the animal. All Surrender Applications are reviewed by our Director and careful and thorough consideration is taken when choosing whether or not to accept a surrendered animal. Factors that would cause us to deny your application include, but are not limited to: (a) our facility is at maximum capacity; (b) there are animals in shelters with an immediate risk of being euthanized; or (c) we do not have the staff, funding, or resources to humanely support the animal.
04. If we determine, at our sole discretion, that you have submitted this Application with false and/or misleading information, your Application will be denied.
05. You may be required to submit additional information and/or take additional steps in order to complete application processing.
06. You acknowledge and agree that you are the sole legal owner of the animal and that you have the legal power to relinquish ownership of the animal to us.
07. You acknowledge and agree that there are no claims, whether criminal or civil, pending against you in relation to the animal.
08. You acknowledge and agree that upon relinquishing your ownership rights of the animal to us, you are not entitled to, guaranteed, or otherwise warranted to reclaim the ownership rights of the animal from us.
09. You acknowledge and agree that you will pay the one-hundred dollar (\$100.00) surrender fee to our organization prior to, or immediately upon, relinquishing the animal to us. The surrender fee can be paid by cash, check, and/or debit/credit card.
10. You acknowledge and agree that you must transport the animal to our facility on a scheduled date and time, determined between you and our Director, to relinquish your ownership rights of the animal.
11. You acknowledge and agree that if it comes to our attention that the animal has been neglected, abused, or been treated cruelty or inhumanely, we will contact the applicable authorities who may further contact you to investigate such cases.
12. You acknowledge and agree to forever release, discharge, and covenant to hold harmless FMAR, and any of our staff, volunteers, or Directors, chargeable with responsibility or liability, their heirs, administrators, executors, successors, and assigns from any and all claims, damages, costs, expenses, loss of service, actions and causes of action belonging to you arising out of any act or occurrence for the present time and particularly on account of your relinquishment of ownership of the animal.
